What: The 12th Annual Super Scenic 72-Mile (And Then Some!) Garage Sale

Where: From Ponte Vedra to Daytona Beach in Volusia County along more than 72 **Miles of Florida Scenic Highways**

When: Saturday, November 21, 2020 from 8 am to 2 pm

Why: Friends of A1A strives to increase visitation to the scenic sites and businesses along the Byway. Attendees are invited to view the Eat, Shop, Play Along A1A! Mobi-Tour via free download from TravelStorys.

How: Friends of A1A uses registration fees to place ads in surrounding county press and internet news media and to provide event signs. Info and signs may be picked up prior to the day of the event.

Required Vendor Participation Waiver:
